WORKS IN PROGRESS OR COMPLETED

- Genus have completed <u>new</u> Eagle Nests surveys on the 2nd of May'25 for the new proposed Palmerston to Sheffield, Sheffield to Burnie and the Heybridge Spur East 220kV Transmission Lines;
- 30% Design completed and submitted to TasNetworks.
- Geotech completed for the Substations
- · Surveys (3D and LiDAR using Drones) for Substations completed
- Geotech commenced on the Transmission Lines on 10 June'25, should be completed by end November'25
- Landowner Liaison is progress, around 25% completed





Contingent Project Application 2



Background

- TasNetworks submits contingent project applications (CPAs) to enable cost recovery for projects not included in our 5 yearly revenue determination.
- The Australian Energy Regulator (AER) accepted our early works costs for Stage 1 NWTD proposed in CPA 1.
- TasNetworks intends to submit CPA 2 in September 2025, which is required to enable recovery of the remaining costs to deliver Stage 1 NWTD.
- Before we can submit CPA 2, we need to update the Project Marinus Regulatory
 Investment Test for Transmission (RIT-T) and request a feedback loop assessment from
 the Australian Energy Market Operator (AEMO)

What's in CPA 2



CPA 2 will capture the remaining costs required to deliver Stage 1 NWTD.

CPA 2 must contain rigorous and transparent capex forecasting methodologies that

underpin each cost category.

 TasNetworks will provide robust justification for all forecast costs

- CPA 2 will include revenue and price impacts
- TasNetworks will consider application of incentive schemes

Feedback loop/ RIT-T update

- TasNetworks must request a feedback loop assessment from AEMO prior to the submission of CPA 2. The AER requires a successful feedback loop prior to making a determination on CPA 2.
- TasNetworks will update the RIT-T to demonstrate no change to the preferred option.
- Both the feedback loop and RIT-T are for "Project Marinus".
- In line with AER expectations, TasNetworks and Marinus will submit a feedback loop request to AEMO and publish the RIT-T update prior to the Marinus Revised Proposal (due July 15).



Next steps

- By 15 July 2025 Undertake RIT-T update and submit feedback loop request to AEMO
- Customer consultation on CPA and cost/price impacts
- By 30 September 2025 Submit CPA 2

- ✓ AER determines cable and converter costs 'prudent and efficient'
 - Revised revenue proposal (to include BoW) due in July
