About the project

The North West Transmission Developments (NWTD) project, being progressed by TasNetworks, is a once in a generation upgrade to the electricity transmission network.

As Tasmania's energy demands increase, TasNetworks needs to strengthen the state's transmission network. NWTD will include new and upgraded transmission lines, substations and switching stations.

The project is proposed to be delivered across two stages. The first stage will link Cressy, Sheffield and Burnie, with the second stage planned between Staverton and Burnie via Hampshire Hills (refer to project map).

NWTD will support new renewable energy developments and generate significant benefits and opportunities for Tasmanian communities and businesses.

The project is currently in the design and approvals phase. Subject to approvals, construction for Stage 1 is due to commence in 2026.

Introduction

This document provides an outline of the engagement activities that were carried out between January and June 2025. It builds on previous engagement reports which you can find here.

We are committed to engaging in a way that is meaningful, fair and achieves the best outcomes for landholders, the community and the environment. Feedback continues to help shape the direction of the NWTD and we remain committed to working alongside Tasmanians as the project progresses.

This report focuses on feedback gathered from stakeholders and the general community about the project and does not include detailed feedback from landholders. Engagement with landholders, each with a dedicated land agent, is ongoing and will continue throughout all phases of the project.



How we have engaged

We engaged with a range of stakeholders and community members between January to June 2025 to raise awareness and collect feedback about the project.

Feedback collected during this phase of the project has helped us understand concerns, the topics that are important to people and what people want to know more about.

Contingent project application approved

In 2024, we submitted a contingent project application (CPA) to the Australian Energy Regulator (AER) to obtain the revenue allowances necessary to undertake early works associated NWTD Stage 1. We were pleased to receive the AER's final decision in March 2025 approving our application. CPAs are necessary for large investments that are made outside of TasNetworks' standard business as usual expenditure, while undertaking early works activities provides confidence to customers that they will pay no more than the efficient cost of delivering this stage of the project.



NWTD head contractor

NWTD hosted a 'meet the head contractor' event in Burnie in early June to provide an opportunity for local contractors and suppliers to find out more about the work packages on offer and connect with representatives from GenusPlus Group (Genus). More than 150 people attended the event, with an overwhelming feeling of support for NWTD as well as the ongoing positive legacy it, and other major infrastructure projects, will have on communities.

Representatives from TasNetworks, Genus and Industry Capability Network Tasmania provided updates, including our Chair Roger Gill who gave details on the two-part contract and procurement.

Panel members Teeny Brumby (Mayor of Burnie), Claire Connelly (President - Devonport Chamber of Commerce & Industry) and Annie Gatenby (North West Regional Development Coordinator - Regional Development Australia) shared their insights into the opportunities and challenges, and the role the region can play to maximise benefits for the NW region.

The evening concluded with a networking session and trade table engagement, including stalls from Skills Tasmania, TasTAFE and West North West Working.

Lodgement of permit application engagement

We held drop-in information sessions and a webinar in April to share the findings of key technical studies conducted as part of the environment, planning and heritage approvals phase, prior to the permit application being placed on public exhibition.

A letter was sent to all NWTD landholders notifying them of the then upcoming lodgement and included an invitation to the drop-in sessions and webinar. Landholders were invited to provide feedback in person at a drop-in session or by contacting their dedicated land agent directly.

A good cross-section of project supporters, community members with reservations about the project and impacted landholders were represented by those attending the information sessions, as well as people seeking general information.

Many attendees demonstrated strong project knowledge having had previous interactions with the stakeholder and landholder engagement teams.

The balanced representation of interests allowed the team to gain further insights about landholder and community concerns and provided the opportunity to respond to these.







Chatting with community members at Agfest

Agfest is Tasmania's premier agricultural event, attracting approximately 60,000 patrons over three days.

This year, the TasNetworks site offered fun and education activities, with a strong focus on being prepared for power outages. Visitors explored interactive displays, picked up safety tips, and got to know our team and what we do.



The NWTD team was on site, joined by our head contractor, Genus. Together, we had a fantastic few days connecting with community members about the project.

The Genus team were able to answer questions about upcoming construction and to provide information for local businesses interested in getting involved.

Congratulations to Rural Youth Tasmania for organising another successful Agfest. We're proud to be a long-standing sponsor of this iconic Tasmanian event and we're already looking forward to doing it all again next year.

Stakeholder Liaison Group

The NWTD Stakeholder Liaison Group (SLG) is an independently chaired group made up of 16 members with representation across key industry groups, peak bodies, education, skills and training sectors and state government organisations. The meetings provide an opportunity for us to understand stakeholder perspectives and receive input and feedback on a range of matters related to the NWTD.

Three SLG meetings were held between January to June 2025 at the Cradle Coast Authority in Burnie. The group discussed a range of topics including:


- Head contractor updates
