1. TUoS is Transmission Use of System.
2. The prescribed transmission prices in the above table have been calculated in accordance with the National Electricity Rules (NER) and TasNetworks' Proposed 2024-29 Pricing Methodology submitted to the Australian Energy Regulator (AER).
3. The table above sets out prescribed transmission network prices and exit prices for connection points to the distribution network only. Prices for generators, non-distributor connection points and non-prescribed transmission services are not included.
4. Prescribed TUoS Services Locational Prices – the customer's contract demand is used to determine the charge.
5. Prescribed TUoS Services Non-Locational Prices – either the capacity or energy price is applicable, depending on whether the customer load factor is above (capacity) or below (energy) the median load factor for Tasmania. Where the capacity price is applicable, the customer's contract demand is used to determine the charge. Where the energy price is applicable, historical energy is generally used to determine the charge.
6. Prescribed Common Transmission Service Price – either the capacity or energy price is applicable, depending on whether the customer load factor is above (capacity) or below (energy) the median load factor for Tasmania. Where the capacity price is applicable, the customer's contract demand is used to determine the charge. Where the energy price is applicable, historical energy is generally used to determine the charge.
7. Prices for connection sites added after 1 July 2024 will be determined through application of TasNetworks' 2024-2029 Transmission Pricing Methodology.
